(NEW) Salvisa, Kentucky, USA-a current worker **(Luther Raine)** with known allegations of child sex abuse and sexual assault is attending and scheduled to speak at this convention on Thursday morning and Saturday evening. This convention is August 22-25, 2024.

(NEW) Salvisa, Kentucky USA-a current worker (Ruthie Topinka) with known allegations of sexual assault is attending and schedule to speak at this convention on Friday morning. This convention is August 22-25, 2024.

*Iron Bridge, Ontario Canada-*a known convicted sex offender (Grant Radbourne) with allegations attended this convention June 13-17 2024.

*Aylesbury, Saskatchewan Canada-*a known convicted sex offender (Phil Robinson) was allowed to attend this convention even after Jim Atchenson sent a letter out about conventions stating the following: "Those with convictions are invited to listen remotely instead of attending in person." This convention is July 18-21, 2024.

Portage, Manitoba Canada-a known friend (Terry Ruda) with allegations attended this convention.

*Gravatai, South Brazil-*a known worker (Bernard Manning) with credible allegations attended this convention. He is an Australian worker currently in the work in Argentina.

Didsbury, Alberta, Canada- a known worker (Marion Crawford) with credible allegations attended this convention. She is a Canadian worker.

Elizabeth 1, Colorado USA--a known perpetrator tried to attend this convention and was prohibited.

Mellowdale, Alberta Canada--a known worker (Marion Crawford) with credible allegations who is still in the work, is scheduled to speak at this convention. She is a Canadian worker.

Iron Bridge, Ontario Canada–a perpetrator (Marvin McDowell-elder) with credible allegations attended this convention. There is an open investigation against him.
